

Gettysburg Case Study: The Gettysburg Inner Loop

What is the goal?

A safe bicycle and walking trail linking schools, shops, homes, and community destinations in Gettysburg









What would be the benefits of the trail?

- Provide a safe close-to-home place to exercise
- Provide a safe alternative form of transportation
- Encourage shopping in Gettysburg commercial areas
- Provide safe ways to school for students
- Provide safe routes to destinations for seniors
- Relieve some traffic congestion
- Reduce pollution from motorized vehicles





How did it start?

Citizens concerned about safe bicycling and walking and the need for healthy exercise opportunities discussed the idea/concept. These citizens included -

- A local bicycle advocate
- Board members of Healthy Adams Bicycle/Pedestrian, Inc.
- Members of Gettysburg Borough Council
- Local college staff





How did it start?

- A couple of the concerned citizens attended a DCNR Trails Summit and learned what other organizations and communities were doing.
- They learned that Gettysburg could get help from The Rivers, Trails, and Conservation Assistance Program of the National Park Service (NPS).
- The concerned citizens applied for NPS assistance with a letter from Gettysburg Borough Council.





How did it start?

- The NPS provided a community planner to work with HABPI and the Gettysburg Borough on the project.
- A steering committee was formed to analyze the need for a trail/route, to find a desired "alignment", and to guide a feasibility study. Several community organizations were represented on the committee.
- Gettysburg Borough Council was a strong participant and supporter.
- Steering committee meetings focused first on key destinations and target audiences.




